## STATE LEADERSHIP CONFERENCE From The Desk of the President

The Annual State Leadership Conference took place in Washington, D.C., March 10-13. Your representatives this year included Brittany Novotny as Executive Director, Laura Hughes as PEC Coordinator, Scott Pribyl as Federal Advocacy Coordinator and myself in the capacity of state president. It was a busy weekend. The main thrust was training leadership to advocate on federal and state levels in the interest of our profession.

This year, the focus was on Medicare in particular. There are three points that APA would like stressed to legislators. The first is postponement of scheduled cuts to Medicare reimbursement.

The second focus was on the inclusion of psychologists for tax credits to update to electronic records. Electronic records

would be used for easy communication between medical/mental health facilities. Medical clinics, VA and other agencies have already been retooling for this eventuality. This bill would make it possible for practitioners to join this system and be reimbursed for a portion of this expense.

The third focus was on the need to extend the definition of those in independent practice to include

#### State Leadership Conference

The conference brings together psychologists from the states, U.S. territories and Canada, along with APA governance and divisions, to advocate for issues important to practicing psychologists. The conference also fosters leadership and effective governance strategies for participating associations.

The 2012 State Leadership Conference took place Saturday, March 10 - Tuesday, March 13, 2012.

### STATE LEADERSHIP CONFERENCE: BRINGING PSYCHOLOGY TO THE TABLE; STATE LEADERSHIP IN HEALTH CARE REFORM. FACUpdate Scott Pribyl, Ed.D.

It is a continuing honor and privilege that I get to report on my 9th SLC, held most recently March 10-13, 2012 in Washington, D.C. and hosted by the American Psychological Association. I wish all SD psychologists could experience the energy, enthusiasm, information sharing and advocating that results from this gathering

of psychologists from all states and territories. It is like being plugged into a battery charger and really helps one reassess where *we* as psychologists are doing well and where we might want to look to change things up. One of the key areas for *growth opportunity* would be to talk with our non-member peers and kindly and lovingly educate them as to the benefits of membership in APA and SDPA for starters.

in APA and SDPA for starters. Our profession needs a strong voice represented by many more psychologists who understand how their support would benefit our profession overall, our patients/clients, and our communities as a whole, not to mention the individual psychologist.

As to the focus of our Hill Visits this year, there were three asks. The first ask is for Congress to replace the seriously flawed Medicare Sustainable Growth Rate (SGR) formula which favors expensive technology based services over cost efficient mental health and primary care. With the current SGR schedule, psychologists face a 32% cut in Medicare payments January 1, 2013. This is of course on top of other cuts we have taken in recent years, most recently experiencing another 5% hit with Congress's failure to extend the mental health add-on in the Middle Class Tax Relief and Job Creation Act of 2012. And remember, private health insurance looks at Medicare rates as a bench mark to set their payment levels as well, so the implications go far beyond just Medicare. The good news for psychologists is that many health care and allied health care professionals are united in asking that SGR be replaced. The challenge is that the fix is a \$300 billion plus proposition so our elected representatives need to hear from all of us on establishing priorities.

The second Hill Visit *ask* this year is once again, to include psychologists in Medicare's *Physician* definition. We remain the only doctorally trained allied health provider not included, with the following groups being included already: dentists; podiatrists; optometrists; chiropractors. Failure to achieve

inclusion in the *Physician* definition results in unnecessary supervision requirements for psychologists by physicians and limits opportunities for patients to receive services, especially in medically under served areas like SD. Again, your voice is needed. Our SDPA Hill Visits followed on the heels of the several well known and established psychiatrists from SD that while supportive of

the SGR fix, were putting forth the American Medical Association stance that psychologists need to remain supervised by physicians as currently required by Medicare regulations. Psychologists are trained to provide services independent of supervision and of course are licensed to practice within the scope of their training. However, more education of our legislators needs to occur because psychologists don't have the *war chest* to compete with the AMA just based on financial resources.

Our third *ask* this year is to make psychologists eligible for HITECH (Health Information Technology for Economic and Clinical Health Act) funding, enabling psychologists and social workers to qualify for Medicare and Medicaid incentive payments for integrating electronic health records into their practices.

I look forward to seeing many of you at our annual conference here in Sioux Falls in May. My encouragement is that you talk with at least one psychologist colleague before that time that may not be a member of SDPA and/or APA, and that you talk with them about the give and take benefits of being involved in the organization(s) that best promote psychology as a profession. It will be better for us. It will better for them. We all receive more when we give more.



### FEBRUARY 2012 APA COUNCIL OF REPRESENTATIVES MEETING SUMMARY Council of Representatives Update

Psychology education and the dissemination of the discipline's scholarship were at the forefront of many of the actions taken by the APA Council of Representatives at its February meeting.

Concerning education in psychology, the Council adopted two new guidelines and approved

funding to update a third. The approved guidelines include a taxonomy for education and training in professional psychology (http://www.apa. org/ed/graduate/specialize/ crsppp.aspx), and a framework for the preparation of teachers of high school psychology (http://www.apa.org/ed/ precollege/topss/index.aspx). The approved funding will support a meeting of a Board of Educational Affairs task force charged with revising the APA Guidelines for the Undergraduate Major in Psychology.

"I was pleased to see the emphasis on education and training throughout the meeting," said Suzanne Bennett Johnson, PhD, who as APA president, served as presiding officer during the Council meeting. "Education – of future psychologists, allied professionals and the public -- is the key to the discipline's future and the impact it can have on society."

In addition to her duties as presiding officer, Johnson updated the Council on her three presidential initiatives, which focus on the nation's obesity crisis, how to attract

The Council also devoted over a half-day of its 2.5 day meeting to a "mega issues" discussion as part of APA's Good Governance Project (GGP). The GGP recently concluded an assessment of the APA governance system and brought forward recommendations designed to more fully align the system with what is needed for a 21st century organization. The data indicated that Council wanted to be engaged in discussing strategic issues that have


engaged in discussing strategic issues that have significant impact on the discipline. Toward that end, Council was provided with a background document for its discussion of how technology will impact psychology and APA over the next decade. The discussion centered on such ideas as using social media in public education, how to train psychology faculty in new technologies, delivering research findings through technology, the role of new technologies in data-sharing, and the creation of psychology apps.

### Other Actions of the Council

- Approved funding for the continuing work on the APA/Association of State and Provincial Psychology Boards/APA Insurance Trust Task Force for the Development of Telepsychology Guidelines.
- Adopted a revised Committee on Animal Research and Ethics Guidelines for Ethical Conduct in the Care and Use of Nonhuman Animals in Research.
- Rejected a proposal to eliminate the dues discount for APA members who are also members of the Canadian Psychological Association.
- Approved a proposal to eliminate the practice of invoicing APA members for unpaid back-year dues.
- Approved two journals a Div. 54 journal: Practices and Services Delivery in Pediatric Psychology, and an American Psychological Association of Graduate Students journal: Translational Issues in Psychological Science.

- Approved a proposal to include an APA teacher affiliate member on the Board of Educational Affairs. The proposal requires a change in the Association's bylaws. It will therefore be put before a vote of the full membership this fall.
- Received the report of the 2011 Presidential Task Force on Immigration.
- Received the report of the 2011 Presidential Task Force on Diversity and Discrimination.
- Approved the 2012 APA budget of \$105.2 million in revenues and \$104.9 in expenses.

Lamberty, PhD, ABPP-CN* is a clinical neuropsychologist with the Noran Neurological Clinic in Minneapolis, MN where she conducts neuropsychological evaluations for a variety of patient populations with CNS/Medical diagnoses. She was previously employed by the Minneapolis VA Health Care System and continues to do some lecturing for the pre- and postdoctoral training program at the VAMC. In addition, she is a

volunteer speaker for the MS (Multiple Sclerosis) Society of Minnesota and lectures to professional and patient groups regarding neuropsychological and psychological effect of MS.

Summary of Conference: The purpose of this conference is to help participants identify common cognitive profiles for a variety of psychiatric client populations. We will also review useful screening tools to help differentiate between normal complaints and possible organic dysfunction. Finally, we will discuss a variety of neurological disorders and their behavioral sequelae as well as treatment techniques and strategies for patients with cognitive impairment. ■

### The 87th Legislative Session Summary

- The Legislature sustained the Governor's line item veto of HB 1058 relating to the Unified Judicial System court automation fund.
- The Legislature sustained the Governor's veto of HB 1228 relating to tax refunds for some energy projects.
- The Legislature sustained the Governor's veto of HB 1248 which would have allowed individuals holding a South Dakota driver's license to carry a concealed weapon without any further permit.
- The Governor's veto of SB 157 which would prohibit local governments from regulating outdoor advertising signs was overturned by the Senate but sustained by the House.
- The Legislature also approved a "style and form" veto to SB 194 relating to funding tax refunds for elderly persons and persons with a disability.

## THE 87TH LEGISLATIVE SESSION Legislative Update

During the 2012 Legislative Session, the SDPA monitored many bills of interest to the profession and your patients. Click http://bit.ly/H2LHAR to find the list of bills that the SDPA monitored along with an explanation of each bill and its current status. Bills that were Tabled or sent to the 41st Legislative Day were killed.

The SDPA monitored bills on a variety of topics ranging from mandatory reporting of child abuse to parenteral rights to involuntary and voluntary commitment processes to the state budget and the impact on reimbursement to providers – just to name a few! Regarding the budget, this year had a more positive tone than last year, when providers experienced significant cuts to reimbursement levels. Although increases for FY 2013 may be considered modest by some, many providers are happy to see them headed in a positive direction and certainly hope to see that trend continue.

On March 19th, the 87th South Dakota State Legislature concluded its 33-day session with its traditional Veto Day. Governor Daugaard issued 5 vetoes since the Legislature left Pierre on March 2nd. Specific actions by the Legislature on Veto Day listed above.

Thank you to the SDPA Executive Committee and Division 1, including Division 1 President, Dr. Mark Perrenoud, for the guidance and assistance provided during the legislative session.

*The CAPP Organization Grant* - The Committee for the Advancement of Professional Practice (CAPP) awarded SDPA an Organizational Development Grant of \$10,500. This money helps with office operations as well as lobbyist services. These grants are made possible from funds collected through the practice assessment. So remember to pay the practice assessment when you pay your APA dues. These monies help SDPA to strengthen the voice of psychology in the state of South Dakota and, as a small state, to have a voice at the national level.
