FAC Update

I have been privileged to serve as the SDPA-APA Federal Advocacy Coordinator from May, 2003 forward. In that time, I have attended 11 State Leadership Conferences in Washington D.C. and have more strongly come to appreciate the benefit of affiliating with the APA and the synergy that is accomplished through the APA and state and territorial associations as we collaborate and join our collective knowledge, resources and connections.

An FAC's responsibilities include the facilitation of grassroots advocacy and political giving, and leading the annual Capitol Hill lobbying visits each March when psychologists meet with their Senate and House Congress members to push for legislation that improves mental and behavioral health access for various stakeholders. Among the accomplishments that have been achieved in recent years, the passage of Mental Health Parity legislation in 2008, and advocacy

that has mitigated the effects of the SGR formula and other potential cuts to Medicare reimbursement rates. Much ongoing work remains to be done, to include psychologists being added under the Medicare physician definition.

I have enjoyed the professional work and the personal relationships I have been afforded as a member of the SDPA Executive Committee, and I could go on and on in outlining my sincere appreciation to many dedicated peers for their past and ongoing efforts to promote psychology for our patients and our profession. I don't want to exclude anyone, but I do want to acknowledge especially my appreciation for the work of Sally Weyer and Jodi Owen over the years. Sally has been a great resource of institutional knowledge for SDPA, and Jodi has been a mover and

a shaker in her various APA affiliations. I am also very appreciative of Brittany Novotny, Rachel Day and the Midwest Solutions team for their professional expertise in guiding SDPA. In addition, I am indebted to the APA Practice Organization and the Government Relations Organization for their tremendous support over the years, to include: Katherine Nordal, Ph.D, Executive Director for Professional Practice; Nan Klein, Ph.D, Federal Advocacy Field Team.

To all of you, named and unnamed, thank you.

In May, I informed the SDPA Executive Committee with mixed emotions that I would "retire" from my FAC duties upon SDPA seeking interested candidates and some very qualified and gifted psychologists asked to be considered. AUGUST 2014 APA COUNCIL OF REPRESENTATIVES MEETING SUMMARY

Council of Representatives Update

COR met August 6th and 8th during the APA Convention in Washington, DC. One of the notable outcomes was a continuance of our recent work on reducing the size of Council, and move toward more nimbleness.

The Good Governance Project and subsequent work groups proposed several options, and last summer, we chose a blend of options that entails one seat for each constituency, plus some added seats to assure diversity.

During this meeting, there was a great deal of discussion on how these additional members would be chosen. It's looking like they will be

submitted/nominated by various means, but selected by the Board of Directors. There will be more to come on this issue in future meetings.

Also at this meeting, our debate was about whether to keep the apportionment concept, stick with the one seat per constituency, or go with "weighted" votes, so that a vote of someone representing a larger constituency would carry more weight than a vote from a member of a smaller constituency. This latter concept was voted down.

Therefore future action will be about how to fill Council seats fairly, with adequate representation, but also working toward nimbleness.

PRESENTERS



Mark Carrier, Ph.D., is a Co-Founder and Co-Director of the George Marsh Applied Cognition (GMAC) Laboratory at California State University, Dominguez Hills. He focuses on the effects of technology upon people in their everyday lives, especially on how technological devices and computer

use relate to multi-tasking madness. He is a Professor in the Department of Psychology, and also is a Primary Investigator in the GMAC Brain Imaging Laboratory.

Dr. Carrier will present the results of research done in his laboratory that are relevant to the computer-based and online behaviors of children, tweens, and teens.

Investigator BJ George has worked for the Pennington County Sheriff's Office for over 10 years. He started out as a Patrol Deputy for approximately four years, then moved into Investigations where he investigated property crimes (burglaries, thefts, etc.) and people crimes (rapes, assaults, homicides, etc.). The last 4 ½ years he has been at Unified Narcotics Enforcement Team (UNET) working narcotic cases.



Bruce S. Fogas, Ph.D., is the Director of Therapeutic Services at Volunteers of America, Dakotas and practices psychology at Lifemarks Behavioral Health Services. He focuses on helping families who are experiencing complex emotional and behavioral problems due to learning,

attention and intellectual disabilities. He is also an Assistant Professor in Psychiatry and Pediatrics at Sanford School of Medicine of the University of South Dakota, and serves as the psychologist on the Center for Disabilities FASD clinic in Sioux Falls.

This workshop will highlight the psychologist's role in the diagnosis and treatment of FASD. Brain Damage associated with prenatal alcohol exposure will be discussed, along with difficulties in identifying FASD versus other psychological problems.
