GOVERNMENT SHUTDOWN DELAYS CMS RELEASE OF 2014 MEDICARE PHYSICIAN FEE SCHEDULE FAC Update

CMS gives notice of delayed release of the Medicare physician fee schedule.

In a notice issued on October 23, 2013, the Centers for Medicare and Medicaid Services (CMS) announced that the final rule on the 2014 physician fee schedule, originally scheduled to be released in early November, has been delayed due to the recent federal government shutdown. CMS will release the

final rule on or before November 27, with the new fee schedule taking effect on January 1, 2014. This year's final rule is of great importance to psychologists since CMS is expected to announce its decision on final payment rates for the new psychotherapy codes.

As mentioned in the information alert distributed on September

9th, we outline the proposed rule and describe the significant cuts to the family of psychotherapy codes. In a comment letter to CMS, APAPO addresses concerns with the declining payment rates for the 2014 psychotherapy codes. APAPO will inform you when the final rule is released.

Sequestration cuts will likely remain in effect: For psychologists and all other Medicare providers, an additional 2% reduction in payments beginning in 2014 – on top of the 2% implemented in 2013.

Sequestration payment reduction: As a result of the Budget Control Act of 2011 and the failure of the Joint Committee on Deficit Reduction to come

to an agreement on \$1.2 trillion in debt savings, sequestration took effect on January 1, 2013. This means for Medicare providers a 2% payment reduction each year through 2021, unless Congress intervenes.

Currently, the House and Senate Budget Committees are in negotiations to address deficit reduction and fiscal year 2014 spending levels. As part of

the legislative agreement passed to re-open the government on October 17, the assigned budget conference committee must submit final recommendations by December 13th. In those negotiations ending the ongoing sequestration cuts continues to be an agenda item. Unless sequestration is ended, it will slice an additional

2% off reimbursement rates for psychologists and all other Medicare providers on January 1, 2014.

In addition to sequestration cuts, once again psychology will have to wage an end-of-year battle to halt the scheduled 24.7% percent Sustainable Growth Rate (SGR) cut. APAPO will keep you advised as Congress works to address this looming problem. An action alert focusing on SGR will be coming in the near future.



THE UNIVERSITY OF SOUTH DAKOTA CLINICAL PSYCHOLOGY PROGRAM **Student Representative Update**

Greetings from the clinical psychology program at The University of South Dakota. Described below is general information pertaining to the program and an update on the current students.

The mission of the Clinical Psychology Program is to prepare clinical psychologists who will work effectively as scientist-practitioners within the culturally diverse world.

TRAINING MODEL AND GOALS

The Clinical Psychology Program adheres to the scientist-practitioner model of training. As a scientist practitioner program, we seek to prepare psychologists who are not only able to generate new knowledge through their research and scholarly activities, but who are also able to be effective consumers of the literature and to effectively integrate science and scientific thinking into their clinical practice. Furthermore, we seek to prepare psychologists who strive to adhere to high ethical and professional standards and who are sensitive to, and advocate for inclusion of, diverse perspectives in their research and clinical activities.

Consistent with the scientist-practitioner training model, the Program has three primary goals:

- To prepare clinical psychologists who are skilled in the interface of theory, science, and practice.
- To prepare clinical psychologists who have the appropriate theoretical background, skills, and experience to function as professionals in a research, clinical, and academic capacity.

• To prepare socially responsible clinical psychologists who demonstrate respect for individual and cultural differences in their contributions to the science and practice of psychology.

PROGRAM EMPHASES AND ORIENTATION

The Program offers a broad exposure to a range of clinical and research training experiences involving a variety of settings and populations.

The Program incorporates an evidence-based approach to its clinical training. While the primary theoretical orientation of the clinical faculty and practicum supervisors is cognitive-behavioral, specific theoretical orientations of individual clinical faculty and supervisors also include behavioral, developmental/systems, and psychodynamic (such as interpersonal; object relations).

Supervised clinical training is available on campus and in the community. Students receive ongoing training through the in-house training clinic, the Psychological Services Center starting in their 2nd year in the program, and opportunities for at least two additional 9-12 month practicum experiences at various sites (i.e., Dakota Counseling Institute; Lewis & Clark Behavioral Health; Mickelson Center for the Neurosciences (HSC); Abbott House/Aspire Counseling; Family Medicine Residency; Jackson Recovery Centers; Winnebago Youth Facility; Psychological Services Center at The University of South Dakota; and Student Rosalie Brueske, M.A.

Counseling Center at The University of South Dakota).

Program faculty maintains active research programs involving laboratory-based research, survey studies, and/or community-based, field research. As such, students are exposed to a diversity of research methodologies, including traditional quantitative methods as well as qualitative and program evaluation approaches. Specific faculty research interests include (1) rural community psychology; (2) cross-cultural/individual differences, with a particular focus on Native American mental health; (3) disaster mental health and psychological first aid; (4) trauma (including interpersonal trauma, generational trauma, and PTSD); (5) ethics and professional issues; (6) substance abuse; (7) integrated health care, and, (8) health disparities.

ADDITIONAL INFORMATION

Clinical Faculty

There are 8 clinical psychology faculty (out of 15 full time Department of Psychology faculty). The Director of the Program is Dr. Barbara Yutrzenka, the Director of the Psychological Services Center is Dr. Beth Boyd, and the Director of the Disaster Mental Health Institute is Dr. Jerry Jacobs.

Clinical Psychology Students

In 2013-2014, there are 30 students in residence, 5 students on internship, and 5 ABD students. Each year, the program has between 60-120 applicants and admits 6-7 students. All students admitted to the Clinical Program are provided graduate assistantships and a tuition reduction to 1/3 of the in-state tuition cost. Current internship sites include: The University of Kansas Medical Center; VAMC in Hampton, VA; Yale University; Texas Health Sciences in San Antonio; and The University of Manitoba Medical School.

Placement of Program Graduates

Since 1971 the program has graduated over 250 Ph.D. clinical psychologists. In the past decade, approximately 12% have chosen to complete specialized research or clinical post-doctoral training after graduation. The remaining 88% have secured their initial employment in the following settings: VA and Military Hospitals (36%); Community Mental Health Centers (12%); Public and Private Psychiatric or General Medical Hospitals (8%); Academic Positions (10%); University Student Counseling Centers (3%); Correctional Settings (5%); Private Practice (2%); and Miscellaneous Other Positions (12%).
